Aviva Health to Host Myrtle Creek Town Hall

ROSEBURG, Ore. – Aviva Health is holding a town hall Tuesday, August 8, from 6:30 p.m. to 8 p.m., at the Myrtle Creek Elks Lodge, located at 106 S. Main Street, Myrtle Creek, giving residents in the area an opportunity to share information about the current state of health care in South County.

Aviva Health has operated a medical clinic in Myrtle Creek since 2008 and opened a dental clinic at a separate location in the area in 2020.
